## WHAT YOU NEED TO KNOW ABOUT OVERDRAFTS AND OVERDRAFT FEES

An <u>overdraft</u> occurs when you do not have enough money in your account to cover a transaction, but we pay it anyway. We can cover your overdrafts in two different ways:

- 1. We have <u>standard overdraft privileges</u> that come with your Share Draft account.
- 2. We also offer <u>overdraft protection plans</u>, such as a link to another account, which may be less costly than our standard overdraft privileges. To learn more, ask us about these plans.

This notice explains our standard overdraft privileges.

## What are the standard overdraft privileges that come with my account?

We do authorize and pay overdrafts for the following types of transactions:

- Checks and other transactions made using your checking account number
- Automatic bill payments

We will not authorize and pay overdrafts for the following types of transactions without your consent.

- ATM transactions
- Everyday debit card transactions

We pay overdrafts at our discretion, which means we <u>do not guarantee</u> that we will always authorize and pay any type of transaction.

If we do <u>not</u> authorize and pay an overdraft, your transaction will be declined.

## What fees will I be charged if Mountain Laurel Federal Credit Union pays my overdraft?

Under our standard overdraft privileges:

- We will charge you a fee of up to \$25.00 each time we pay an overdraft
- There is no limit on the total fees we can charge you for overdrawing your account

## What if I want Mountain Laurel Federal Credit Union to authorize and pay overdrafts on my ATM and everyday debit card transactions?
